As not all part numbers will transfer at the same time customers may still receive Products from the Menlo Park location after this transfer date and due to inventory we will carry to allow this transfer to happen and to minimize impact to our tubing customers. Where necessary TE will continue with internal qualification and testing of products after they are received at the new locations.
