Overview

- Resin manufacture has claimed Force Majeure to Molex at the end of May, No Guarantee of Recovery Time frames from their Shanghai plant. But their Nansha plant can support the same grade of material, in order to support continuity, Molex decided to accept the Vendor's proposal.
 - Current Material Source : Shanghai in China
 - New Material Source : Nansha in China
- Molex team will take necessary qualification action on new location material to ensure the same performance on Molex product. Considering the necessary qualification and only location change on resin. Molex supposes this should be low risk on product. The estimated implementation date is on 15th Oct, 2021.
- Product Impact**
 - Material type used in impacted part numbers list is not changing, only the location of where the product is produced & purchased, "no impact to fit, form, function".
