

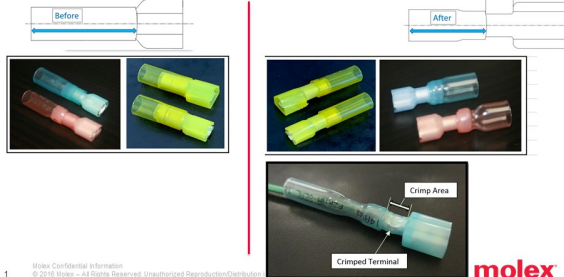

After Change

Overview

- Molex is realigning (shorten) the Heat-Shrink Tubing in order to provide a clear crimp area over the insulated conductor barrel. This will impact Perma-Seal Coupler Quick-Connects, Red 22-18 awg, & Yellow 12-10 awg.
 - There's No Impact in overall length, fit, form or function of these products.
 - These terminals are already UL/CSA Certified and crimped without heat shrink tubing in the crimping area.
