**Description of Changes**

This Product Change Notification (PCN) is to inform you about a resin supplier base extension for the 3pos Plug housing of the mentioned part numbers, which are under the design responsibility of TE Connectivity. This PCN is informational only and no further actions are necessary from your side, as this extension does not have any impact to form, fit or function change. The material itself will remain PA66-GF as stated on the general TE customer drawing. The PN in scope of this PCN is a general sales / catalogue part. Therefore, no contractual agreement related to sub-supplier selection is applicable. VDA 2 Trigger matrix use case 30 and PPAP towards customer/s are not applicable too. TE Change process follows a strict procedure, which fully maintains quality and ability to supply. Internal release process is ensured by TE, including product validation.
