

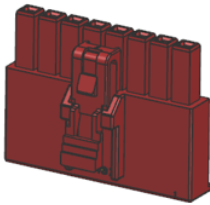

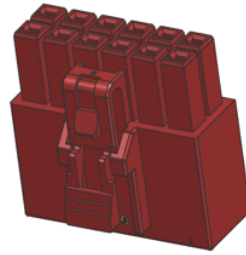

Overview

- This PCN is to develop new capacity for Nano-Fit Receptacle housing (105307 and 105308) to replace the capacity of aged tools in vendor plant to support the production and fulfill the demand:
- They will also add new inserts for housing (105307) 3 and 4circuits onto existing 8 cavity mold.
- The site (Shanghai plant) will move housing (105308) 10,14 and 16circuits by adding new inserts onto existing 8 cavity mold. They will also add new tool for 4 cavity mold for housing for (105307) 5 and 8circuits
